



Angola

- Visas are not required by SA Passport holders for tourist visits for a maximum stay of 30 days per visit. Non-South African passport holders must have proof of permanent residence for South Africa stamped in their passport.
- The Angola visa law changed in September 2023 for SA Passport holders. You only require a visa now if you are visiting the following locations in Angola –
 - Cabinda
 - Travelling off shore
 - Visiting a mine

Valid passport with a minimum of 6 months validity (after the return date of planned trip). Passport must have a minimum of 3 blank pages, and a certified copy of the BIOMETRIC PAGE of passport	✓

Please ensure that traveller has a valid South African ID/Work/Study/Resident permit that is valid for a minimum of 6 months validity (After the return date back to SA) Processing times on foreign passport often vary – please contact our offices for details. Valid Original passport with a minimum of 6 months validity (after the return date of planned trip).



Original and clear photocopy of Yellow Fever Immunization Card	
FULLY completed application form (completed in black ink in block letters and signed by the applicant) ALL questions MUST be answered in full	
2 x Identical COLOUR passport photographs taken against a white background. (Must not be older than 30 days) Size: 45mm x 35mm (please do not wear a white or light-coloured shirt/top when having the photos done, no smiling, no headgear etc)	
DO NOT CONFIRM OR PAY FOR AIR TICKETS until visa is processed. Copy of Flight Itinerary showing planned routing for trip – including exit from SA and return to SA. (Within the 10 day dates on the visa)	
Employment letter: Letter confirming employment, stipulate trip details and must be addressed to the Angolan Embassy in Pretoria.	
<p>Official letterhead of inviting company - must be addressed to : Embaixada Da Republica De Angola Na Africa Do Sul, Sector Consular - Pretoria Invite letter must request a 10 day short stay visa, reflect all applicants details and trip details. ID copy of the host is required to follow the invite letter along with the below documents;</p> <p>Inviting company documents required : Diario Da Republica : Government Gazette certificate of inviting company Alvara Comercial : CC papers of inviting company Documento De Arrecadacao De Receitas : Revenue certificate document of inviting company Documento De Liquidacao De Impostos : Tax certificate of inviting company Cartao De Contribuinte : Card Contributor of inviting company</p>
