ELITE VISAS CAN ASSIST YOU WITH A MEET AND GREET FOR YOUR BIOMETRICS

Biometric data is collected through a quick, discreet and a non-intrusive process that captures a facial image using a digital camera and a 10-digit fingerprint scan on a dry scanner machine. This process will be familiar to applicants who have travelled to other countries requiring biometric data collection. Australian visa applicants will need to attend in person any one of the four (4) Australian Visa Application Centres (AVACs) to provide their biometrics. These AVACs managed by the Australian Government's Service Deliver Partner TLScontact, are located in Cape Town, Durban, Johannesburg and Pretoria.

IMPORTANT NOTE:

Please note that the Australian High Commission advises that the ticket NOT be purchased until the visa is issued. A ticket is not a requirement to apply for the visa. Elite Visas will not be held responsible should the visa not be ready by the <u>proposed</u> travel date.

The Australian High Commission have advised that they no longer require the actual passport to issue Australian visas, A clear passport copy is required, and most visas will be "label free". The applicant will be sent an email-copy of his visa (or letter of refusal) once the application has been processed. The visa will be sent to the e-mail address provided by the applicant on the application form.

The High Commission however does reserve the right to ask for any passport and may opt to rather insert a normal visa into the passport.

PLEASE NOTE THAT ANY DOCUMENTATION THAT IS NOT IN ENGLISH MUST BE ACCOMPANIED BY AN **OFFICIAL** ENGLISH TRANSLATION.

ELECTRONIC TRAVEL AUTHORITY (ETA)

ETA's are available at no visa charge to the holders of the passports listed below. An ETA is valid for a period of three months for tourism and business. A valid passport is required. No application form is required
