### **TRANSIT VISA**

- SA Passport holders require a transit visa if in transit for more than 8 hours or wanting to leave the airport.
- Biometric data collection at the High Commissions visa centre by appointment only is required. Exclusive Global Visas will assist you by making your appointment for you and will have a representative meet you to assist on appointment day.

## **IMPORTANT NOTE:**

Please note that the Australian High Commission advises that the ticket NOT be purchased until the visa is issued. A ticket is not a requirement to apply for the visa. Exclusive Global Visas will not be held responsible should the visa not be ready by the <u>proposed</u> travel date.

The Australian High Commission no longer require the actual passport to issue Australian visas, A clear passport copy is required, and most visas will be "label free".

The visa decision will be sent to Exclsuive Global Visas who will then send the visa copy to you with instructions.

The High Commission however does reserve the right to ask for any passport and may opt to rather insert a normal visa into the passport.

PLEASE NOTE THAT ANY DOCUMENTATION THAT IS NOT IN ENGLISH MUST BE ACCOMPANIED BY AN **OFFICIAL** ENGLISH TRANSLATION.

TRANSIT VISA REQUIREMENTS	✓
One application form (876) and one 956 authority form for all applicants is required. All minors travelling must also have form 1229 completed by both parent's.	
A certified copy of the bio-data page of the passport is required + A copy of National ID	
One passport size photograph	
Minors traveling alone require a certified letter of consent from both parents or certified letter of consent from parent not traveling with AS WELL as a form 1229	
For all minors under the age of 18, traveling with or without parents, a certified copy of the FULL UNABRIDGED birth certificate is required.	
A copy of your flight itinerary and visa for your final destination is required	

### **PROCESSING TIME**

Up to 6 weeks (once received at Australian High Commission)

# **ELECTRONIC TRAVEL AUTHORITY (ETA)**

ETA's are available at no visa charge to the holders of the passports listed below. An ETA is valid for a period of three months for tourism and business. A valid passport is required. No application form is required
