- Visas are required by South African passport holders and all passport holders

<u>REQUIREMENTS – BUSINESS VISA</u>	<u>✓</u>
Passport. Passport must be valid for at least 6 months from validity of visa	
One application form completed in full and signed by the applicant.	
One passport size photo	
Copy of air ticket	
If travelling inland the specifications of the vehicle to be used are need as well original copies of registration (chassis number etc.)	
Proof of residence status in South Africa is required for Non-SA passport holders	
A letter of invitation from the company in Ethiopia is required addressed to “The Federal Democratic Republic of Ethiopia – Immigration and Citizenship Service” Please also provide a copy of the inviting companies Commercial license and TIN certificate	
A self explanatory detailed letter from the SA company must be submitted	
Proof of accommodation is required (hotel booking)	

PROCESSING TIME

4 working days

One application form completed in full and signed by the applicant	
One colour passport size photo	
Copy of air ticket	
Proof of sufficient funds (Bank statement for the last three months)	
Proof of accommodation is required	
If travelling inland the specifications of the vehicle to be used are needed as well as original copies of registration (chassis number etc)	
Proof of residence status in South Africa is required for Non – SA passport holders	

PROCESSING TIME
