





- Visas are required by all passport holders and must be obtained prior to arrival.
- The Embassy of The Republic of The Gambia issues single entry visas that are valid for 90 days from date of issuance.

Delays: Generally 2-4 working days.

Consular hours: Monday to Friday 09h30-12h30

REQUIREMENTS	<u> </u>
Passport with validity of not less than 6 months after return from Gambia is required. Non SA Passport holders must provide proof of legal residence in South Africa. Passport must have at least one blank visa page	
Visa application form to be completed in full and signed	10,
2 colour passport size photos	
Copy of flight ticket is required showing entry and departure from Gambia.	coc
Proof of sufficient funds (3 months bank statement all applicants buisness and tourist) as well as 3 months pay slips for tourist visits.	
Employers letter introducing the application, applicants position, detailed reason for the visit and guarantor's (inviters) details. This is required for buisness and tourist applications.	
A letter of invitation (either host company or individual) explaining the relationship to the applicant and the purpose of travel to Gambia is required. In addition, the letter must indicate the length of stay, place of stay (including full address and telephone number) and all contact information. A copy of the hosts passport must be included or residence permit if not a Gambian Citizen.	
Proof of confirmed reservation if staying in a hotel is required. The confirmation must be from the hotel on the hotels letterhead and signed
