



New Zealand - Business Visa

- New Zealand Visas are applied for online.
- You do not need to appear for biometrics
- All documents can be scanned via email for loading
- The e-visas are valid for one year for a stay of 6 months at a time.

80% of applications are processed within 4 weeks from date of Submission

Requirements –	
1. Application form	
2. Scanned Photo of the applicant	
3. Copy of the applicants Passport	
Copy of Previous New Zealand Visa	
Copy of last exit stamp out of New Zealand	
6. Copy of the applicants ID	
7. Proposed Travel Itinerary	
8. Invite letter – Must specify dates, details of Business trip, address, contact details and be signed	
9. Copy of the inviter's passport	
 If the inviter has a SA passport – 	
Copy of the inviters work permit	
10. Employment letter –
