



- Visas are NOT required by South African passport holders
- Visas are NOT required by British passport holders
- Visas are NOT required by EU passport holders

REQUIREMENTS	✓
Valid passport with a minimum of 6 months validity (<i>after the return date of planned trip</i>). Passport must have a minimum of 3 blank pages	
FULLY completed application form (<i>completed in black ink in block letters and signed by the applicant</i>) ALL questions MUST be answered in full.	
2 x Identical COLOUR passport photographs taken against a white background. (<i>Must not be older than 30days</i>) Size: 45mm x 35mm (<i>no smiling, no headgear etc</i>)	
Photocopy of return flights clearly showing all flight sectors (<i>including to/from RSA</i>) and a detailed itinerary showing all dates is required.	
Proof of confirmed hotel accommodation for each night you are out of RSA.	
Business Applications , Letter from SA Employer stating nature of business, travel dates, position held and period of employment.	
Business Applications , A faxed letter of invitation from company abroad, stating full address, nature of business to be conducted and that the company will be financially and, medically responsible as well as provide accommodation for the applicant.	
Original Forex receipt or an Original bank letter is required stating that applicant has sufficient funds to travel. Should your spouse/parent/partner be responsible for financial means, please supply a letter from spouse/parent/partner confirming responsibility and provide proof (<i>latest 3 months bank statements stamped by bank as well as a copy of their ID</i>)	
The following additional documents will be required for any minor travelling with a Parent: Unabridged Birth Certificate, Certified copies of parents ID's + Consent letter from each parent not accompanying minor.	

IMPORTANT: All Business Visa applications: Please in addition to above, the Embassy requires a letter from the company inviting or financing the traveler/s indicating the objectives of travel. On departure, travelers with Business visas need to hand to the airport authorities a letter indicating if any taxable income was generated during their stay in Peru. Proof of payment of taxes should be submitted or a guarantee that the Peruvian company involved will pay these taxes.

PROCESSING TIME

7-15 working days.
