# **REQUIREMENTS:**

- 1. Original of the Passport and copy of it.
- 2. Passport is valid for more than six months.
- 3. There are at least two blank pages in the passport facing each other.
- 4. Proof of resident from Non-South African passport holders. Non-South African passport holders are required to provide valid visa in South Africa.
- 5. Enjaz registration is mandatory for entry into the Kingdom of Saudi Arabia. The Enjaz registration process will be completed by the Visa Service Centre staff for the applicant. Applicant must acknowledge the correctness of the information before signing the Enjaz form.
- Approved Invitation letter / Visa document issued by the host company in Saudi Arabia from MOFA
- 7. Original Letter of employment from applicant company in South Africa. Employment letter format must be as below: Directed to: Embassy of the Kingdom of Saudi Arabia /Consulate section manager. Subject: Business visit visa request (validity of the visa either Single entry or 365 days multiple entry) Employment letter to confirm the below: Applicant name, Passport number, Job title, starting date within the company and purpose of visit. Company business of the Applicant company in South Africa. Interested Business between both parties. Employment letter to include the company letterhead and mention the below: Official website for the company, Official email address, contact numbers, company registration number, address, and company stamp. Confirmation from the applicant company that applicant will be visiting Saudi Arabia on their behalf and to state the name of the company in Saudi.

Please note the following: \* Applicant can apply for Business visit visa only if visiting the KSA on behalf of his / her company in SA or overseas and not as individuals. \* Required documents may change if applicant is not working in South Africa and applicant company is not based in South Africa.

## **PROCESSING TIME**

For applications received in the same city as the Royal Embassy/ Consulate of the Kingdom of Saudi Arabia, the documents are sent for processing to the respective Embassy/ Consulate on the next working day. For all other locations, the documents will reach the respective Embassy/ Consulate within 2 working days.

The likely processing time for the visa will depend on the completeness and accuracy of the documents provided by the applicant. Tasheer takes no responsibility for the accuracy and completeness of the documentation.
