REQUIREMENTS (FOR THOSE WHO REQUIRE A VISA)

Entry requirement for all foreigners

Visa application is required for citizens / passport holders of the following countries:

Nationals of Assessment Level I Countries

India, Democratic People's Republic of Korea, People's Republic of China, Holders of Hong Kong Document of Identity, Macau Special Administrative Region (MSAR) Travel Permit, Georgia, Turkmenistan, Ukraine, Commonwealth of Independent States (Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Uzbekistan)

Nationals of Assessment Level II Countries

Afghanistan, Algeria, Bangladesh, Egypt, Iran, Iraq, Jordan, Kosovo, Lebanon, Libya, Morocco, Mali, Nigeria, Pakistan, Saudi Arabia, Somalia, Sudan, Syria, Tunisia, Yemen and holders of Palestinian Authority Passport, Temporary Passport issued by the United Arab Emirates and Refugee Travel Document issued by Middle-East countries
