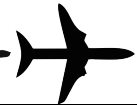
<u>REQUIREMENTS FOR A BUSINESS VISA</u>	✓
Applicant has to submit following documents to this High Commission 14 days prior to travel to Sri Lanka to get a Business visa.	
Duly filled application (form B)	
A copy of the ticket reservation and hotel reservation	
The documents to prove the reason to travel to Sri Lanka	
Invitation letter
